H. F. No. 32, A bill for an act relating to legacy; prohibiting payment of certain indirect costs from legacy funds; amending Minnesota Statutes 2018, sections 16A.127, subdivision 8; 85.53, by adding a subdivision; 97A.056, by adding a subdivision; 114D.50, by adding a subdivision; 129D.17, by adding a subdivision.
