Outside of youth sports, I've never worn a uniform. A uniform to serve this country or our communities. For about 20 years I wore a suit in corporate America. Just a few years ago I left to care for a sick child (who is now thriving) and never looked back. With the support of my incredible wife, I took the path of small business ownership and am still grinding away to live that dream. From the beginning of this phase of my life, one of the many pleasures of being my own boss is the opportunity to choose where the funds go when there is any extra. Certainly, it starts with bills and the bank and taxes. After that we hope that there is enough left to help fuel good work somewhere.

As that decision point came upon us, we were blessed to meet Chris Tetrault and the Hometown Hero Outdoors organization. They were coming into their own about the same time my journey as a business owner was doing the same. A few of those extra dollars needed a home and it was quickly that I realized HHO was going to be a part of that.

My body and mind were spared the damage of war or service. However, the damage of war didn't spare my family. My grandfather, Lyle Frolund served in World War 2. He returned to Fargo, ND where it was apparent his body was largely unharmed, but his mind was not. My mother shared stories about waking up to him screaming from his bedroom in the middle of the night. Those screams were only silenced by the bottle of E&J on the top shelf of his closet. Eventually these screams broke apart his family and he drank himself to death alone in Fergus Falls, MN. The scars of that war didn't stop with him. My mother was unable to maintain her 2 marriages. I made a painful decision to remove her from my life in 2016 so that I could stand between my children and the mental damage she continues to carry with her.

In the late 90s, I met one of the most incredible men in my life. My father-in-law, Gaylon Entgelmeier. Gaylon served in the jungles of Viet Nam. Like many he came home to a largely ungrateful unempathetic country. As a testament to the man he is, he put his head down and went to work. He delivered mail in St. Paul, drove school busses, and cleaned a bar at night. Nobody can quite explain when he slept. But he and his wife Lana raised 3 beautiful daughters and have 4 grandchildren.

A few years ago I was on a fishing boat talking to Galen about his retirement future and what he planned to do with the surprisingly comfortable savings he'd accumulated. Assuming he'd talk about a boat or some travel he slammed me again with the character I'd grown to love and appreciate. He sighed and said "well, nobody was ever there for me and I will be there for my granddaughters. I'm going to help them go to college."

The pride in which he expressed that was muffled to me by the beginning of his sentence. "Nobody was ever there for me". I realized that would be the same thing my grandpa would say if he was still with us. Nobody was ever there for them.

When I met Chris and the crew at Hometown Hero Outdoors that landed on me. These people are being there for men and women who need them. They show up with passion and empathy and love in a genuine mission to help put these people back together and let them know they aren't alone. Furthermore, in this day of screens and devices they get them OUTSIDE. Away from the stresses and trappings of modern life. Many being able to engage with a passion they've long had, making it even more conducive to opening up and receiving that support. Or, for the first time getting outside and experiencing a whole new world where they can let it go and bond with those who understand their struggles.




