

1.1 ..... moves to amend H.F. No. 7 as follows:

1.2 Page 5, line 5, after the period, insert "The assigned corrections agent for a person who  
1.3 is required to register under this paragraph and who was sentenced before July 1, 2025,  
1.4 must notify the person of the duty to register by July 31, 2025. If the person does not have  
1.5 a corrections agent but has an obligation to register under this section, the bureau must  
1.6 provide notice to the person and the law enforcement authority with jurisdiction over the  
1.7 person's primary address. A person who is required to register under this paragraph and  
1.8 who was sentenced before July 1, 2025, must register within 30 days of receiving notice of  
1.9 the obligation to register. A person who is required to register under this paragraph, was  
1.10 sentenced before July 1, 2025, and was a juvenile at the time of sentencing may petition  
1.11 the sentencing court to waive the registration requirement."

1.12 Page 5, after line 5, insert:

1.13 "Sec. 3. Minnesota Statutes 2024, section 243.166, subdivision 2, is amended to read:

1.14 Subd. 2. **Notice.** When a person who is required to register under subdivision 1b,  
1.15 paragraph (a) or (e), is sentenced or becomes subject to a juvenile court disposition order,  
1.16 the court shall tell the person of the duty to register under this section and that, if the person  
1.17 fails to comply with the registration requirements, information about the offender may be  
1.18 made available to the public through electronic, computerized, or other accessible means.  
1.19 Except as provided for in subdivision 1b, paragraph (e), the court may not modify the  
1.20 person's duty to register in the pronounced sentence or disposition order. The court shall  
1.21 require the person to read and sign a form stating that the duty of the person to register under  
1.22 this section has been explained. The court shall make available the signed court notification  
1.23 form, the complaint, and sentencing documents to the bureau. If a person required to register  
1.24 under subdivision 1b, paragraph (a), was not notified by the court of the registration  
1.25 requirement at the time of sentencing or disposition, the assigned corrections agent shall

2.1 notify the person of the requirements of this section. If a person required to register under  
2.2 subdivision 1b, paragraph (a) or (e), was not notified by the court of the registration  
2.3 requirement at the time of sentencing or disposition and does not have a corrections agent,  
2.4 the law enforcement authority with jurisdiction over the person's primary address shall  
2.5 notify the person of the requirements. When a person who is required to register under  
2.6 subdivision 1b, paragraph (c) or (d), is released from commitment, the treatment facility  
2.7 shall notify the person of the requirements of this section. The treatment facility shall also  
2.8 obtain the registration information required under this section and forward it to the bureau."
