1.4 is amended to read:

1.5 Subdivision 1. **Requirements.** (a) To improve academic excellence, improve ethnic
1.6 and cultural diversity in the classroom, and close the academic achievement gap, the
1.7 Board of Teaching must approve qualified teacher preparation programs under this section
1.8 that are a means to acquire a two-year limited-term license, which the board may renew
1.9 one time for an additional one-year term, and to prepare for acquiring a standard license.
1.10 The following entities are eligible to participate under this section:

1.11 (1) a school district or charter school that forms a partnership with a college or
1.12 university that has a board-approved alternative teacher preparation program; or

1.13 (2) a school district or charter school, after consulting with a college or university
1.14 with a board-approved teacher preparation program, forms a partnership with a nonprofit
1.15 corporation organized under chapter 317A for an education-related purpose that has a
1.16 board-approved teacher preparation program.

1.17 (b) Before participating in this program, a candidate must:

1.18 (1) have a bachelor's degree with a 3.0 or higher grade point average unless the
1.19 board waives the grade point average requirement based on board-adopted criteria;

1.20 (2) pass the reading, writing, and mathematics skills examination under section
1.21 122A.09, subdivision 4, paragraph (b); and

1.22 (3) obtain qualifying scores on applicable board-approved rigorous content area and
1.23 pedagogy examinations under section 122A.09, subdivision 4, paragraph (e).

1.24 (c) The Board of Teaching must issue a two-year limited-term license to a person
1.25 who enrolls in an alternative teacher preparation program. This limited-term license is not
1.26 a provisional license under section 122A.40 or section 122A.41.

2.3 Subd. 10. **Negotiated unrequested leave of absence.** (a) The school board and
2.4 the exclusive bargaining representative of the teachers may negotiate a plan providing for
2.5 unrequested leave of absence without pay or fringe benefits for as many teachers as may
2.6 be necessary because of discontinuance of position, lack of pupils, financial limitations, or
2.7 merger of classes caused by consolidation of districts. ~~Failing to successfully negotiate~~
2.8 ~~such a plan, the provisions of subdivision 11 shall apply.~~ The negotiated plan must not
2.9 include provisions which would result in the exercise of seniority by a teacher holding a
2.10 provisional license, other than a vocational education license if required for the position,
2.11 contrary to the provisions of subdivision 11, clause paragraph (c), or the reinstatement of a
2.12 teacher holding a provisional license, other than a vocational education license required
2.13 for the position, contrary to the provisions of subdivision 11, ~~clause (e) paragraph (f).~~
2.14 The provisions of section 179A.16 do not apply for the purposes of this subdivision.
2.15 Notwithstanding other law to the contrary, the school board and the exclusive bargaining
2.16 representative of the teachers may negotiate a plan to base unrequested leave of absence
2.17 decisions on teachers' subject matter licensure fields and evaluation outcomes, from the
2.18 least to most effective category under subdivision 8 and from least to greatest seniority
2.19 within each category, which if negotiated, must be consistent with subdivision 11,
2.20 paragraph (n).

2.21 (b) Notwithstanding other law to the contrary, if a school board fails to successfully
2.22 negotiate a plan under paragraph (a), the provisions of subdivision 11 apply unless a
2.23 majority of school board members formally decides to place teachers on unrequested
2.24 leave of absence based on teachers' subject matter licensure fields and evaluation
2.25 outcomes, from the least to most effective category under subdivision 8 and from least

3.8 Subd. 11. **Unrequested leave of absence.** The board may place on unrequested
3.9 leave of absence, without pay or fringe benefits, as many teachers as may be necessary
3.10 because of discontinuance of position, lack of pupils, financial limitations, or merger
3.11 of classes caused by consolidation or reorganization of districts under chapter 123A.

3.12 The unrequested leave is effective at the close of the school year. In placing teachers on
3.13 unrequested leave, the board is governed by the following provisions:

3.14 (a) The board may place probationary teachers on unrequested leave first in the
3.15 inverse order of their employment. A teacher who has acquired continuing contract rights
3.16 must not be placed on unrequested leave of absence while probationary teachers are
3.17 retained in positions for which the teacher who has acquired continuing contract rights is
3.18 licensed;

3.19 (b) Teachers who have acquired continuing contract rights shall be placed on
3.20 unrequested leave of absence in fields in which they are licensed in the inverse order
3.21 in which they were employed by the school district. In the case of equal seniority, the
3.22 order in which teachers who have acquired continuing contract rights shall be placed on
3.23 unrequested leave of absence in fields in which they are licensed is negotiable;

3.24 (c) Notwithstanding the provisions of ~~clause~~ paragraph (b), a teacher is not entitled
3.25 to exercise any seniority when that exercise results in that teacher being retained by the
3.26 district in a field for which the teacher holds only a provisional license, as defined by the

 4.14 reinstated to a position in a field in which the teacher holds only a provisional license,

 4.17 The order of reinstatement of teachers who have equal seniority and who are placed on
 4.18 unrequested leave in the same school year is negotiable;

 4.20 unrequested leave, a teacher who is properly licensed to fill such vacancy, unless the

 4.23 of the position to which appointed on a future date determined by the board;

5.9 (n) Beginning in the 2015-2016 school year and later, and notwithstanding any
 5.10 contradictory provisions in this subdivision, a school board must place teachers on
 5.11 unrequested leave of absence based on their subject matter licensure fields and most recent
 5.12 evaluation outcomes, from the least to most effective category under subdivision 8 and
 5.13 from least to greatest seniority within each effectiveness category. A school board is not
 5.14 required to reassign a teacher with more seniority to a different subject matter licensure

5.26 Sec. 4. Minnesota Statutes 2011 Supplement, section 122A.41, subdivision 6, is
 5.27 amended to read:

5.28 Subd. 6. **Grounds for discharge or demotion.** (a) Except as otherwise provided
 5.29 in paragraph (b), causes for the discharge or demotion of a teacher either during or after
 5.30 the probationary period must be:

5.31 (1) immoral character, conduct unbecoming a teacher, or insubordination;

5.32 (2) failure without justifiable cause to teach without first securing the written release
 5.33 of the school board having the care, management, or control of the school in which the
 5.34 teacher is employed;

6.1 (3) inefficiency in teaching or in the management of a school, consistent with
6.2 subdivision 5, paragraph (b);

6.3 (4) affliction with active tuberculosis or other communicable disease must be
6.4 considered as cause for removal or suspension while the teacher is suffering from such
6.5 disability; or

6.6 (5) discontinuance of position or lack of pupils.

6.7 Notwithstanding other law to the contrary, the school board and the exclusive
6.8 representative of the teachers may negotiate an agreement to discharge or demote teachers

6.19 later, and notwithstanding any contradictory provisions in this subdivision, the school

6.22 category under subdivision 5 and from least to greatest seniority within each effectiveness

6.29 teacher's license has been revoked due to a conviction for child abuse or sexual abuse.

6.32 Subd. 14. **Services terminated by discontinuance or lack of pupils; preference**

6.34 clause (5), a teacher whose services are terminated on account of discontinuance of
6.35 position or lack of pupils must receive first consideration for other positions in the district

7.2 one or more positions, in making such discontinuance, teachers must be discontinued in
7.3 any department in the inverse order in which they were employed, unless a board and the

7.17 of a teacher who is similarly licensed and effective but with less seniority. "A substantially
7.18 different grade level assignment" means an assignment between kindergarten, grades 1
7.19 through 6, junior high school, and senior high school.

7.20 (d) Notwithstanding the provisions of clause paragraph (a), and to the extent
7.21 consistent with paragraph (c) and subdivision 6, paragraph (a), a teacher must not be

7.32 more existing districts, each teacher employed by an affected district shall be assigned to
7.33 the newly created or enlarged district on the basis of a ratio of the pupils assigned to each
7.34 district according to the new district boundaries. The district receiving the greatest number
7.35 of pupils must be assigned the teacher with the greatest seniority, and the remaining

8.1 teachers must be alternately assigned to each district until the district receiving the fewest
8.2 pupils has received its ratio of teachers who will not be retiring before the effective date of
8.3 the consolidation or dissolution.

8.4 (b) Notwithstanding paragraph (a), the board and the exclusive representative of
8.5 teachers in each district involved in the consolidation or dissolution and attachment may
8.6 negotiate a plan for assigning teachers to each newly created or enlarged district.
