1.14 (2) a justice of the Minnesota Supreme Court;

1.15 (3) employees of the Minnesota judicial branch;

1.16 (4) judicial referees and magistrate judges; and

1.17 (5) current and retired judges and current employees of the Office of Administrative  
1.18 Hearings, Workers' Compensation Court of Appeals, and Tax Court.

1.19 (c) "Personal information" does not include publicly available information. Personal  
1.20 information means:

1.21 (1) a residential address of a judicial official;

1.22 (2) a residential address of the spouse, domestic partner, or children of a judicial official;

2.1 (3) a nonjudicial branch issued telephone number or email address of a judicial official;

2.2 (4) the name of any child of a judicial official; and

2.3 (5) the name of any child care facility or school that is attended by a child of a judicial  
2.4 official if combined with an assertion that the named facility or school is attended by the  
2.5 child of a judicial official.

2.6 (d) "Publicly available information" means information that is lawfully made available  
2.7 through federal, state, or local government records or information that a business has a  
2.8 reasonable basis to believe is lawfully made available to the general public through widely  
2.9 distributed media, by a judicial official, or by a person to whom the judicial official has  
2.10 disclosed the information, unless the judicial official has restricted the information to a  
2.11 specific audience.

2.12 (e) "Law enforcement support organizations" do not include charitable organizations.

2.13 (f) "Real property records" has the meaning given in section 480.50, subdivision 1,  
2.14 paragraph (f).

2.15 **EFFECTIVE DATE.** This section is effective January 1, 2026."
