This table does not include the designated on-road routes located in state forests, nor does it include state forest roads not intended for ATV recreational use (individual campsite roads and service roads were not included). Also of note, classifications are not mutually exclusive and there can be overlap.

Of trail miles open to ATVs, only 7.8 percent do not allow Class 2 ATVs. These routes are narrower ATV/OHM trails, and the vast majority are located in Region 2.

Designated on-road routes are an essential component for the connectivity and experience of much of Minnesota's ATV trail system. These routes make up about 43 percent of the overall designated trail system in the state.
