1.6 (b) "Correctional fees":

1.7 (1) effective August 1, ~~2027~~ 2029, means fees charged or contracted for by a probation
1.8 agency or the commissioner of corrections for court-ordered or community-provided
1.9 correctional services, including but not limited to drug testing, electronic home monitoring,
1.10 treatment, and programming; and

1.11 (2) effective August 1, 2023, through July 31, ~~2027~~ 2029, include fees for the following
1.12 correctional services:

1.13 (i) community service work placement and supervision;

1.14 (ii) restitution collection;

1.15 (iii) supervision;

1.16 (iv) court-ordered investigations;

1.17 (v) any other court-ordered service;

1.18 (vi) postprison supervision or other form of release; and

1.19 (vii) supervision or other probation-related services provided by a probation agency or
1.20 by the Department of Corrections for individuals supervised by the commissioner of
1.21 corrections.

1.22 (c) "Probation" has the meaning given in section 609.02, subdivision 15.

2.1 (d) "Probation agency" means a probation agency, including a Tribal Nation, organized
2.2 under section 244.19 or chapter 401.

2.4 Subd. 7. **Annual report.** (a) By January 15 each year, the commissioner must submit
2.5 an annual report on implementing the commissioner's duties under this section to the chairs
2.6 and ranking minority members of the senate and house of representatives committees and
2.7 divisions with jurisdiction over criminal justice funding and policy. At a minimum, the
2.8 report must include information on the types of correctional services for which fees were
2.9 imposed, the aggregate amount of fees imposed, and the amount of fees collected.

2.10 (b) This subdivision expires August 1, ~~2027~~ 2029.

2.11 Sec. 3. Minnesota Statutes 2024, section 244.18, subdivision 9, is amended to read:

2.12 Subd. 9. **Sunsetting supervision fees; sunset plan.** (a) By August 1, 2025, each probation
2.13 agency must provide to the commissioner a written plan for phasing out supervision fees
2.14 for individuals under the agency's supervision and control, and the commissioner must
2.15 review and approve the plan by August 1, ~~2027~~ 2029. By August 1, ~~2027~~ 2029, the
2.16 commissioner must develop a written plan for phasing out supervision fees for individuals
2.17 under the commissioner's supervision and control.

2.18 (b) A copy of an approved plan must be provided to all individuals under the supervision
2.19 and control of the agency or the commissioner and in a language and manner that each
2.20 individual can understand.

2.21 (c) Supervision fees must not be increased from August 1, 2023, through July 31, ~~2027~~
2.22 2029.
