We need a regional approach to support the unique needs of our most complex young people including placement options for:

- High Acuity-most intensive behaviors (e.g. highly aggressive, sexually acting out) in need of immediate treatment support and not housed in Emergency Rooms or County offices.
- Secure Detention: Locked facilities to provide short-term safety, accountability and support for teens charged with the most serious crimes.
- Non-secure: Unlocked facilities designed to provide safety, accountability and support to young people in the juvenile justice or child welfare system.



Scott County, through the JAF, has *increasingly* been serving the need for a *non-secure facility* for children for the region. It is in need of repairs and/or a new location. We need the State to help address a regional approach supporting the unique needs of our most complex young people as well as to invest in the needed infrastructure for the regional approach across all types of facilities.

Regional framework for youth with complex mental health needs

HENNEPIN COUNTY MINNESOTA

Youth in crisis

A small but significant population of county-involved youth have unmet needs due to complex mental health diagnoses, behaviors, and trauma. Gaps and barriers in the current system leave these youth without treatment options, forcing them into inappropriate placements that are far from their support systems and oftentimes more damaging.

Youth with complex needs may be involved with multiple systems, including human services and juvenile justice systems. In addition, Minnesota licenses and certifies placement facilities separately from treatment programming, which means youth can't always access appropriate services.

Fundamental structural reform is needed. At this time, a group of metroarea and other counties is developing a regional plan to enhance and improve the continuum of care, serving county-involved youth with a whole-person, cross-system approach.

This plan is built on the recommendations of the 2024 Working Group on Youth Interventions, and will include the voice of the youth and families most impacted.

Immediate response: crisis stabilization center

To address one of the most acute gaps in services, Hennepin County is funding and opening a youth crisis stabilization center at our Behavioral Health Center at 1800 Chicago Avenue in Minneapolis.

Target population and services

- Youth with complex behavioral health needs, regardless of which system they enter
- Residential crisis stabilization for youth who cannot remain safely at home: treatment and therapeutic supports while triage, assessment, and planning take place with families
- Culturally responsive services delivered by a community agency, intended to reduce the deep racial disparities concentrated in this part of the system
- 10-15 beds for short-term stays of 30-45 days

Long-term response: regional framework offering continuum of care

Anoka, Carver, Dakota, Hennepin, Scott, Ramsey, and Washington counties in the metro, plus St. Louis, Olmsted, and Stearns counties in outstate Minnesota, are collaborating to leverage their individual and collective strengths and capacities to create a continuum of services, facilities, and care that supports youth with complex mental health needs and their families.

Leaders and staff from participating partner counties will jointly identify actionable reforms, innovative solutions, and broad strategies to fill the gaps in the care continuum.

Legislative proposals

As this effort begins, several legislative policy changes have been identified that would have both immediate and longer-term impacts on maximizing capacity and getting care for the young people who need it.

- Licensing and certification
- Medicaid benefit policy
- Reimbursement rate structure

Hennepin County policy and funding proposals

Regional framework for youth with complex mental health needs

Metro-area and partner counties are working together to improve the continuum of care, serving county-involved youth with a whole-person, cross-system approach.

Policy proposals

As this effort begins, we have identified several legislative policy changes that have both immediate and longer-term impacts on maximizing capacity and getting care for the young people who need it.

Licensing and certification

Establish a legislative task force including the Minnesota Department of Children, Youth, and Families (DCYF), Department of Human Services (DHS), Department of Corrections (DOC), Direct Care and Treatment (DCT), counties, providers and community members to provide specific licensing standards for unique levels of care, for children's residential mental health facilities covered under Minn. R. 2960.0580 to 2960.0690.

Allow an exception to the current moratorium on youth beds to expand capacity of licensed child foster residence settings, adding placement options for least restrictive treatment options (disability waiver system).

Modify Minn. R. 2960.0710 regarding training for restrictive procedures licenses to be trauma-responsive and include culturally appropriate and responsive practices.

Medicaid benefit policy

Inmate Exclusion/Reentry Waiver

Direct the State Medicaid Agency-DHS to prioritize full implementation of the federal direction under the Consolidated Appropriation Act (CAA), requiring states to provide certain health care services for eligible youth incarcerated in correctional institutions.

Crisis Stabilization Benefit

Direct the State Medicaid Agency-DHS to expedite the implementation of the benefit "residential crisis stabilization for children."

Reimbursement rate structure

Require DHS to begin phased implementation of the 2023 non-residential rate study recommendations by July 1, 2025.

Require DHS to conduct a review of the financial model for residential children's facilities by July 1, 2026.

Create a temporary fund for the existing seven children's residential treatment facilities until the financial review offers guidance for the administration by host counties.

Funding the regional framework

The participating counties are each committed to partnering in the continuum of services. To fill the most pressing gaps and shortages, we are seeking some immediate short-term funding to narrow service gaps, offer critical programming and support the build out of the regional framework.

Areas of identified need include:

Stabilizing staff

Incentives, training, rate increases, and support for critical front-line and clinical staff.

- Funding programming and services Funding for community provider programming in juvenile detention centers or shelters, as well as care coordination with community mental health for transitions out of care.
- Supporting facilities and providers Maximizing capacity and effectiveness in existing facilities; supporting temporary rate increase for children's residential facilities.
- Building out the regional continuum of care framework

Framework planning and development of implementation road map; data sharing model.

 Addressing gap funding for operational costs for crisis stabilization center Reimbursement for operational costs for Hennepin

County's crisis stabilization center until Medicaid benefit is in place.
