Dear Chair McDonald and Chair Vang:

As metro regional park implementing agencies, we are writing with shared concerns and opposition to the H.F. No. 2563DE1 Amendment. In Article 3, Sec. 4 it states the following:

(b) \$100,000 the first year and \$100,000 the second year are for grants to Wilderness Inquiry to connect Minnesota youth and families to natural resources through activities that support parks and trails of regional significance within the seven-county metropolitan area.

We appreciate the opportunity to express our strong opposition to the proposed earmark legislation that would allocate Parks and Trails Legacy funds to a nonprofit organization, contrary to the clear constitutional intent of the Legacy Amendment. These funds are expressly dedicated to benefit state, regional, and Greater MN park and trail agencies—public entities that are accountable to taxpayers and have a proven track record of stewarding these resources for the public good.

When Minnesota voters approved the Legacy Amendment, they did so with the understanding that funds would be used transparently and equitably to support publicly managed parks and trails. Earmarking public dollars for a private nonprofit—no matter how well-meaning—undermines that promise and sets a dangerous precedent that weakens accountability, public oversight, and constitutional integrity.

Our park and trail systems are among the most cherished assets in our communities. They rely on stable and appropriately allocated funding to maintain accessibility, environmental stewardship, and public trust. Redirecting funds to a nonprofit not only diminishes the resources available to these agencies, but also violates the spirit of the Legacy Amendment.

I urge you to remove this provision and protect the constitutional framework that voters overwhelmingly support.

The *Parks and Trails Legacy Plan* recommends how the Parks and Trails Legacy Fund should be used. The Parks and Trails Fund, one of the four funds created by the Clean Water, Land and Legacy Amendment passed in 2008, receives 14.25% of the money raised by the sales tax increase. The purpose of the amendment is to provide supplemental financial resources to traditional funding sources for support of

state and regionally significant park and trail systems. The 40/40/20 allocation between the DNR/Metro Parks and Trails/Greater MN Parks and Trails has been in place for over 15 years and has proven to be successful.

As always, we remain grateful for the work that you do with our agencies to provide vital park spaces and programs to metro area residents, and all the health, recreation and economic benefits that come from this investment.

HF2563 - Wilderness Inquiry Legacy Request, Arts & Cultural Heritage Fund

Chairs and Members of the House Legacy Finance Committee:

**Thank You for including Wilderness Inquiry in the Legacy Finance Bill** (HF2563 DE1 amendment), which we view as recognition of the impactful work we do every year in some 40 communities across Minnesota.

Our programming model, known as Canoemobile, is unique in that it shows up where the kids are in neighborhoods and townships in every corner of the state. Wilderness Inquiry believes **Everyone Belongs in the Outdoors**, and we make sure every kid—regardless of their abilities or background—can participate in meaningful outdoor experiences and hands-on activities that teach Minnesota history and our shared cultural heritage.

As an organization, we would respectfully request consideration of our appropriation request included in the bi-partisan House File 1328, led by co-authors Rep. Spencer Igo and Rep. Fue Lee, from the Arts & Cultural Heritage Fund, which we feel is the best fit for the program content that we deliver with Legacy dollars. The DE1 amendment would shift funding to the Parks & Trails Fund, which presents a number of challenges for funding Wilderness Inquiry programming given the wide range of locations we serve.

Legacy is an important source of funding for our organization and makes an outsized impact for Minnesotans. Reductions in Legacy support will reduce this impact statewide. **At a flat appropriation level, we will be able to serve nearly 10,000 Minnesota youth and caring adults (at a cost of just \$112/participant)** through our progression of outdoor educational and recreational opportunities. Wilderness Inquiry is also proud to leverage Legacy support, matching nearly \$3 in philanthropic and earned revenues for every \$1 invested by the State of Minnesota.

From day-long schoolyard outdoor programs to extended overnight adventures across Minnesota's wide range of public lands and waterways, Legacy support helps ensure that Wilderness Inquiry can deliver programs that center Minnesota's history, outdoor heritage, and cultural connections to the natural world—and do so with attention to making the experiences accessible to everyone.

We write to you, as dedicated members of Minnesota's conservation community, to express support of the funding recommendations for the Outdoor Heritage Fund forwarded to you by the Lessard-Sams Outdoor Heritage Council (LSOHC) and included in HF2563.

This nation-leading Outdoor Heritage Fund was created when Minnesotans voted overwhelmingly in 2008 in favor of the Clean Water, Land & Legacy Amendment. With that vote, Minnesotans called for acceleration of conservation in Minnesota and full transparency of spending decisions and outcomes. The structure and process followed by the LSOHC has met and continues to meet those expectations.

This year's funding package was unanimously approved by the LSOHC before being submitted to the legislature. The recommendations contain 50 high priority conservation projects across the state, in addition to more projects that will be funded through the Conservation Partners Legacy Grant Program. The selected projects have been thoroughly vetted by the LSOHC through its competitive, public process, which received over \$400 million in requests and resulted in recommendations to you that total \$162.886 million.

In considering full approval of the recommendations, we encourage you to reflect on the following:

- 1. LSOHC members are citizens and legislators chosen for their expertise in conservation from a statewide perspective. The LSOHC is well-qualified to select projects that are urgent and most likely to return positive results from taxpayer investment.
- 2. The LSOHC's competitive grant application process is thorough, fair and transparent. It demands that proposals are well-designed, high-priority, science-based projects that address conservation goals enumerated by LSOHC and state plans.
- 3. The LSOHC adheres to a rigorous review process each year to determine its final recommendations for the Legislature. It prioritizes projects based upon several criteria, including urgency, reasonableness and ability of the proposer to achieve the outcomes.
- 4. The conservation projects recommended by the LSOHC are urgent and ready to implement.
- 5. LSOHC and the Minnesota DNR developed the Conservation Partners Legacy Grant Program, which sub-grants funding to smaller, community-level conservation projects. This popular Outdoor Heritage Fund program funds projects up to \$500,000.

The LSOHC package presented to you is worthy of your support. We are available as a resource to you and thank you for your support of conservation in Minnesota.

The League of Women Voters of Minnesota is proud to be nonpartisan, neither supporting nor opposing candidates or political parties at any level of government, but always working on vital issues of concern to members and the public. With our statewide membership of more than 2,200 members representing 33 local Leagues across the state, we envision a democracy where every person has the desire, the right, the knowledge and the confidence to participate.

# LWV Minnesota strongly supports HF1740 because of the importance of local community media to our mission of empowering voters and defending democracy.

Many of our local Leagues rely on community stations for their nonpartisan candidate forums and informational programs. For example, the League of Women Voters of White Bear Lake Area (LWVWBLA) worked in partnership with four community stations: Lakes Area TV, Nine North, Suburban Community Channels, and Valley Access Channels to record 18 candidate forums this past fall. These channels broadcast the forums live, re-played them numerous times, and made them available to post on LWVWBLA's own YouTube channel. In total, local Leagues held **198 forums** that have reached 63,193 views.

In 2024, CCX Media recorded and published 22 forums, shared candidate statements and provided election night reporting to communities across the west metro despite absorbing more than \$1.8 million in lost revenue since 2017. While they have met the demand online, cut costs and utilized ads, CCX and other trusted stations are struggling with the decline of cable.

Please include HF1740 in the Legacy bill, HF2563, to ensure that communities around the state can continue to rely on local media as a trusted source of information in our democracy.

Dear Co - Chair McDonald Co-Chair Vang and members of the committee,

On behalf of the Minnesota Corn Growers Association's (MCGA) nearly 7,000 members I appreciate the opportunity to provide written comments in support of several programs within the Clean Water Fund (CWF) article of the DE-1 amendment for HF 2563.

We encourage the Clean Water Council (CWC) and the legislature to continue to find ways to maximize CWF dollars for on the ground projects. We are happy to see a few of the programs listed below being recommended that will help give farmers the tools they need to make decisions and apply farming techniques that will provide clean water benefits for all Minnesotans.

MCGA strongly supports the following recommended programs:

Conservation Equipment Assistance- We greatly appreciate the Council adding this program recommendation two years ago. Since then, farmer interest in soil health practice implementation has been proven out by the tremendous popularity of this program. Since this program's original inception as a pilot in 2022 MDA has received over \$24.5 million in funding requests vs the \$5.2 million that has been made available from general and clean water funds. The upfront cost of retrofitting or buying new equipment is often the biggest barrier to farmers as they look for ways to implement different tillage or cover cropping systems on their farms as well as the broader suite of practices that can enhance soil health and improve water quality. Prior to this program the only options available to farmers who were interested in trying a new practice and offsetting some of the risk, was either through a cost-share program and/or renting equipment through their local SWCD. These programs may have had farmer interest, but they were not designed for large scale adoption. It is our view that the best way to expand adoption of these practices is by farmers owning their own equipment and working with other farmers to do custom work. We would encourage the legislature and the CWC to consider this when evaluating the various soil health programs that currently exist to encourage farmer adoption of soil health practices.

**AgBMP Loan Program**- The AgBMP Loan Program complements several programs including the Conservation Equipment Assistance Program that will allow Minnesota farmers to take advantage of low interests loans and begin to implement soil health practices to benefit clean water.

**MDA Technical Assistance** – We appreciate the CWC's and the legislature's continued support for this program as it funds research for on-farm demonstrations like Discovery Farms that increases education and promotion of best management practices on the farm.

**Expanding the Ag Weather Station Network (MDA)**- These weather stations give farmers the local information they need to make the best possible agronomic decisions regarding planting dates, crop protection application timing, and more. This detailed local information will create opportunities to more effectively utilize crop protection chemical applications. With precise information on disease risk due to weather conditions, farmers can delay disease prevention applications until risk is high in their area. Additionally, information on when weather conditions are favorable for effective crop protectant application means less unusable applications, which has a benefit for water quality in Minnesota. We strongly support the funding recommendation.

# RESOLUTION IN SUPPORT OF STATE LEGISLATION TO MODERNIZE FUNDING FOR LOCAL COMMUNITY "PEG" (PUBLIC / EDUCATION / GOVERNMENT) PROGRAMMING

WHEREAS, the Northern Dakota County Cable Communications Commission ("NDC4") is authorized by its seven Member Cities (Inver Grove Heights, Lilydale, Mendota, Mendota Heights, South St. Paul, Sunfish Lake and West St. Paul) to negotiate and manage the cable franchise agreements of the seven cities, to provide local government programming, and to contract with the non-profit corporation Town Square Television ("TST") to provide local community Public Education and Government ("PEG") programming; and

**WHEREAS**, for over thirty-five years, NDC4 and TST have provided essential local coverage of community events and issues, non-profits and charities, school sports and academic programs, business, chamber of commerce and tourism, school board, city, county and state government meetings, candidate information and election coverage, local history, public health and education, music, arts and other uniquely local programs that broadcast stations typically do not cover; and

**WHEREAS**, in light of rapidly decreasing local media, Town Square Television is the principal, and in some cities the only professional media source providing local video and online coverage; and

WHEREAS, NDC4 and TST are funded through franchise fee and PEG fee support negotiated in the cable franchise agreements with local cable providers, which are currently limited to ONLY the revenues on traditional cable TV and NOT on streaming or internet revenues; and

**WHEREAS**, NDC4 and TST are projecting an ongoing substantial loss of franchise fee and PEG fee revenues due to the marketplace trend of "cord cutting" (traditional cable TV subscribers migrating to multiple digital video service providers that are currently NOT required to support local community PEG programming); and

WHEREAS, NDC4 and TST distribute essential local community programming on multiple platforms including cable TV, online streaming, and social media, to ensure access to all residents regardless of their income level or choice of technology; and

**WHEREAS**, "MACTA" (Minnesota Association of Community Telecommunications Administrators) supports legislation to Modernize the Funding for Local Community PEG Programming.

**NOW, THEREFORE, BE IT RESOLVED** that the NDC4 Cable Commission offers their support to the "MACTA" (Minnesota Association of Community Telecommunications Administrators) effort to modernize local community Public, Education, and Government ("PEG") programming funding through legislative change, consistent with federal law.

I am writing in regard to provisions in the <u>DE1 amendment</u> to <u>HF 2563</u> (Vang, McDonald), the House's omnibus Legacy bill, that relate to the Met Council.

### **Regional Parks and Trails**

The Metropolitan Council supports the continued 40-40-20 split of the parks and trails funding found in the <a href="DE1">DE1</a> <a href="mailto:amendment">amendment</a>. The Parks and Trails Legacy Fund is shared between the Metropolitan Council, the Department of Natural Resources, and Greater Minnesota Parks and Trails. The 40% of funds allocated to the Met Council are passed through to the 10 regional parks implementing agencies, which use Legacy funds to ensure that the metro region has access to high-quality recreational opportunities. This vital funding fuels our efforts to connect people and the outdoors, acquire land and development opportunities, and take care of the existing system.

The Metropolitan Council has concerns about the \$200,000 appropriation from Regional Parks and Trails funding to Wilderness Inquiry found in Article 3, Section 3. The Council supports the Governor's recommendations for distribution of parks and trails funding that supports the regional parks implementing agencies in their efforts to connect youth and families to the abundant natural resources in our regional parks and trails.

### **Clean Water Fund Recommendations**

The Metropolitan Council also supports the Governor's and Clean Water Council's recommendations for the Clean Water Fund. The <u>DE1 amendment</u> to <u>HF 2563</u> includes two recommendations related to the Met Council. Adjusted for the February budget forecast, the recommendations include:

- Water Sustainability Program: \$2.75 million for the FY26-FY27 biennium would support local actions that
  address emerging drinking water supply threats and overall water sustainability, provide cost-effective
  regional solutions, leverage inter-jurisdictional coordination, support local implementation of wellhead
  protection plans, and prevent degradation of groundwater and surface water resources.
- Water Efficiency Grant Program: \$1.4 million for the FY26-FY27 biennium would allow the Met Council to
  give grants to cities and townships served by a municipal water supply system to offer residents rebates or
  grants to replace toilets, washing machines, dishwashers, and more with efficient appliances, install
  advanced metering infrastructure technology to better prevent loss of water from major leaks, install smart
  irrigation systems, and allow municipalities to conduct water audits.

I am writing to encourage including appropriation for community cable television stations like CCX Media in the House Legacy Omnibus Bill. CCX Media provides essential local coverage and public information to the cities of Brooklyn Center, Brooklyn Park, Crystal, Golden Valley, Maple Grove, New Hope, Plymouth, Osseo, and Robbinsdale.

CCX Media is projecting an ongoing substantial loss of franchise fee and PEG (Public, Educational, Governmental) fee revenues due to the marketplace trend of cord cutting, as traditional cable television subscribers migrate to streaming TV services that are not required to support local community PEG programming.

The Legacy Fund appropriation will provide funding for valuable community programming at the most local level. Dear Co-Chairs McDonald and Vang and members of the Legacy Committee,

On behalf of our organization—Greater Minnesota Parks and Trails (GMPT)—we are writing to provide feedback on H.F. 2563 DE1, the Omnibus Legacy Bill. GMPT is a non-profit advocacy organization made up of more than 135 cities, counties, parks groups, individuals, and others who seek to connect people to the outdoors and improve the quality of life for Minnesotans. Many of our local government members operate parks and trails that are designated as regionally significant and eligible to receive funding from the Legacy Fund. As explained below, we appreciate the 20% allocation to Greater Minnesota but ask that the Committee cap the grant fees awarded to the DNR and shift the appropriation of \$50,000 from Greater Minnesota's Legacy funds to Wilderness Inquiry back to the Arts and Cultural Heritage Fund or a different resource.

### The Importance of Regional Parks and Trails in Greater Minnesota.

Regional parks and trails play an essential role in our recreation systems throughout Minnesota. They serve as a bridge between the local park around the corner and Minnesota's outstanding state parks. Regional parks and trails are a close-to-home option for both the community and visitors. They serve as the bridge between Minnesota's state parks and trails and local ones, offering unique and larger scale recreation opportunities closer to home.

Regional parks and trails have existed outside the metro area for decades, but they were not truly recognized until after the passage of the Legacy amendment in 2008, and subsequent discussions shed light on the fact that the regional parks and trails of Greater Minnesota were being ignored. In 2013, the Legislature created the Greater Minnesota Regional Parks and Trails Commission (GMRPTC), which has been tasked with developing a system of regionally designated facilities in the 80 counties not served by the Metropolitan Council. Since then, 81 facilities-parks, trails, special features, and supportive partnerships across the state have been designated as regional through a rigorous evaluation process. This designation makes them eligible to receive Legacy Funding.

### **Funding for Greater Minnesota Regional Parks and Trails**

The Regional Parks and Trails of Greater Minnesota are woefully underfunded. Until 2023, their only source of funding was a 20% share of the Legacy Fund. In 2023, the Legislature dedicated 1.5% of Lottery-in-lieu funds to Greater Minnesota as well, a welcome addition though not nearly as much as the 22% that the Metro and the DNR receive from that same fund. Greater Minnesota's regional parks and trails do not have the same access to bonding or general fund resources either.

We want to thank this committee for continuing to recognize the importance of our parks and trails by allocating 20% of the available funds this year to Greater Minnesota. As we further explain below, we urge the Committee to devote as much of those funds as possible to projects at the regionally designated facilities in Greater Minnesota.

### **Capping the DNR's Grant Fees**

The current version of this bill would allow the DNR to recover up to 2.5 % of Greater Minnesota's share of the Legacy fund for the actual costs to administer grants. We urge the Committee to follow the lead set forth in H.F. 489 instead and cap the fee at a flat rate of \$140,000 per year, freeing up more than \$300,000 during the biennium for projects. That amount is an infinitesimally small portion of the DNR's budget but can make a significant difference for our members. That funding could go to the creative grantmaking that enabled a partnership between Isanti, Wright, and Stearns County for a mobile fleet of winter gear that gets people of all ages outdoors and helped create a mobile mountain bike fleet in Duluth to assist underserved kids and adults who are learning to bike. It could add potable water to a park reserve and trail head or rehabilitate a section of trail. However the funds are used, please know they will be put to good use.

### **Funding Locally based Outdoor Programming**

We are deeply concerned with the portion of the bill that would allocate a portion of Greater Minnesota's legacy funds to Wilderness Inquiry, a metro-based (Bloomington) nonprofit with national and international operations. Our members respect the work of Wilderness Inquiry but believe that its history and culture-based learning it provides should be funded through the Arts and Cultural Heritage Fund as it has been in the past. There are multiple reasons that Greater Minnesota's Regional Parks and Trails funding should not be awarded in this manner:

- As explained earlier, the regional parks and trails of Greater Minnesota are already woefully underfunded. This allocation cuts into those scarce funds.
- The Greater Minnesota Regional Parks and Trails Commission is already engaged in creative grantmaking to connect more people with the outdoors. For example, the mobile winter fleet and mobile mountain bike fleet mentioned above allow multiple facilities to provide equipment and programming on an ongoing basis to underserved communities. Other designated facilities have used the connection grants to obtain Track Chairs (all-terrain electric wheelchairs) that allow people of all abilities to get off the pavement and on trails.
- Awarding the funds through the Commission instead helps to ensure that long-term investments can be made by organizations that are already based in Greater Minnesota.

We appreciate all the time and energy this committee has put toward assembling this bill. Thank you for your time and consideration.
