progress toward substantial conformity and the standards not being met do not impact the
interests and well-being of the persons confined or incarcerated in the facility. A limited
license under subdivision 1a may be issued for purposes of effectuating a facility closure.
The commissioner may grant licensure up to two years. Unless otherwise specified by
statute, all licenses issued under this chapter expire at 12:01 a.m. on the day after the
expiration date stated on the license.

The commissioner shall have access to the buildings, grounds, books, records, staff, and 3.7 to persons confined or incarcerated in these facilities. The commissioner may require the 3.8 officers in charge of these facilities to furnish all information and statistics the commissioner 3.9 deems necessary, at a time and place designated by the commissioner. Notwithstanding 3.10 chapter 13 or any other state law classifying or restricting access to data, the officers in 3.11 charge of these facilities must furnish all data available to the facility that the commissioner 3.12 deems necessary to conduct a review of any emergency or unusual occurrence at the facility. 3.13 Failure to provide or grant access to relevant information or statistics necessary to fulfill 3.14 inspection or emergency or unusual occurrence reviews, as requested by the commissioner, 3.15 may be grounds for the commissioner to take action against a correctional facility's license 3.16 under subdivision 1a, 1b, or 1c. 3.17

All facility administrators of correctional facilities are required to report all deaths of individuals who died while committed to the custody of the facility, regardless of whether the death occurred at the facility or after removal from the facility for medical care stemming from an incident or need for medical care at the correctional facility, as soon as practicable, but no later than 24 hours of receiving knowledge of the death, including any demographic information as required by the commissioner.

All facility administrators of correctional facilities are required to report all other 3.24 emergency or unusual occurrences as defined by rule, including uses of force by facility 3.25 staff that result in substantial bodily harm or suicide attempts, to the commissioner of 3.26 corrections within ten days from the occurrence, including any demographic information 3.27 as required by the commissioner. The commissioner of corrections shall consult with the 3.28 3.29 Minnesota Sheriffs' Association and a representative from the Minnesota Association of Community Corrections Act Counties who is responsible for the operations of an adult 3.30 correctional facility to define "use of force" that results in substantial bodily harm for 3.31 reporting purposes. 3.32

the inspection. The education program offered in a correctional facility for the confinement
or incarceration of juvenile offenders must be approved by the commissioner of education
before the commissioner of corrections may grant a license to the facility.
