### Overview

This bill makes a number of changes to the Livestock Market Agency and Dealer Licensing Act and the Minnesota Department of Agriculture's (MDA) food inspection and enforcement authority.

| 1 | <b>Livestock dealer agent.</b><br>Modifies the name of the defined term "agent" to "livestock dealer agent."   |
| 2 | <b>Meat packing companies, packers, and slaughtering houses.</b><br>Modifies the name of the defined term "packing plants and slaughtering houses" to "meat packing companies, packers, and slaughtering houses." Changes the definition to places of business "in the business of (1) buying livestock for purposes of slaughter, (2) manufacturing or preparing meats or meat food products for sale or shipment, or (3) marketing meats, meat food products, or livestock products in an unmanufactured form acting as a wholesale broker, dealer, or distributor." |
| 3 | <b>Buying station.</b><br>Makes conforming change for section 2.   |
| 4 | <b>Meat packing company agent.</b><br>Adds a definition of "meat packing company agent" under the Livestock Market Agency and Dealer Licensing Chapter.  |
| 5 | <b>Licensing provisions.</b><br>Requires meat packing companies and their agents be licensed under the Livestock Market Agency and Dealer Licensing Act. Allows licenses to be renewed annually after the initial issuance.  |

<b>Section</b>	<b>Description</b>
6	<b>Application.</b> Makes a conforming change for section 5.
7	<b>Surety bonds required.</b> Strikes citation to the session law that established the Livestock Market Agency.
8	<b>Refusal to license.</b> Makes conforming changes for section 5.
9	<b>Revocation of license.</b> Removes the availability of a hearing if a licensee loses their dealer license.
10	<b>Suspension of license.</b> Makes a conforming change for section 9.
11	<b>Hearing on claims.</b> Modifies the requirements for Livestock Market Agency and Dealer Licensing Act hearings on the bonds that reimburse the seller if the buyer does not make a payment, including requiring the MDA to make an initial determination on the validity of the claim and notifying the licensee to pay the claim.
12	<b>Public notice.</b> Makes conforming changes for section 5 and 11.
13	<b>Prohibited conduct.</b> Makes conforming changes for sections 5 and 11.
14	<b>Record keeping.</b> Allows the MDA to take enforcement actions against businesses who are required to retain records under the Livestock Market Agency and Dealer Licensing Act.
15	<b>Fee.</b> Allows MDA to accept payment from exporting companies requesting certificates of health, sanitation, purity, free sale, origin, etc. with the initial request for certification before having to bill the exporting company.
16	<b>Food sampling and demonstration.</b> Clarifies language for food product sampling or demonstrations.

Section	Description
17	<b>Reporting requirements.</b> Gives the MDA permissive authority to require annual reporting from packers when the authority is currently mandatory.
18	<b>Enforcement required.</b> Includes the Livestock Market Agency and Dealer Licensing Chapter under the MDA's Food Inspection and Enforcement authority.
19	<b>Repealer.</b> Repeals the rabies proclamation requirement and the written bill of sale for sellers of branded livestock requirement.
