

# Direct Care and Treatment Recodification

June 2024

### **Executive Summary**

The 2023 Legislature established Direct Care and Treatment as a separate state agency, moving these functions from within a division of the Department of Human Services. This publication illustrates the new organization of statutes governing the programs, services, and functions of the Department of Human Services that are being transferred to the new Direct Care and Treatment agency, effective July 1, 2025.

Direct Care and Treatment is currently a division of the Minnesota Department of Human Services (DHS) that delivers publicly funded residential, nonresidential, and treatment services to persons with complex needs. It provides services through state-operated programs for individuals who display complex conditions associated with mental illness, substance use disorder, developmental disabilities, traumatic brain injury, neurocognitive disorders, individuals who are committed to the commissioner of human services as mentally ill and dangerous, and those who are committed as sexually dangerous persons or as having a sexual psychopathic personality.

Direct Care and Treatment provides services for clients at the Minnesota Sex Offender Program (MSOP), hospitals, treatment programs, and residential locations throughout the state, and through partial hospitalization, outpatient services, and mobile crisis teams.

The legislature directed nonpartisan staff to recodify the statutes to reflect the implementation for the transfer of duties, as reflected in the enacted legislation. The recodification was enacted in two parts: Laws 2024, chapter 79, relating to the transfer of duties, and chapter 127, relating to the Direct Care and Treatment executive board and chief executive officer. The recodified statutes are mainly contained in Minnesota Statutes, chapter 246 (state-operated services), chapter 246C (direct care and treatment), and some other chapters related to miscellaneous issues.

### **2023 Enacted Legislation**

Minnesota Laws 2023, chapter 61, article 8, now codified as Minnesota Statutes, chapter 246C, establishes Direct Care and Treatment as a separate state agency, effective July 1, 2025.

The 2023 legislation also directed the nonpartisan legislative staff to "prepare legislation for introduction in the 2024 legislative session proposing the statutory changes necessary to implement the transfers of duties" required by the 2023 legislation. Laws 2024, chapter 79 is the product of this direction from the legislature to the nonpartisan legislative staff.

The legislature also directed the commissioner of human services to "prepare legislation for introduction during the 2024 legislative session ... for the creation and implementation of the Direct Care and Treatment executive board and defining the responsibilities, powers, and functions of the Department of Direct Care and Treatment executive board."

### **2024 Enacted Legislation**

Laws 2024, chapter 79, made all the necessary changes to Minnesota Statutes to transfer to the Direct Care and Treatment executive board all the duties and authorities currently vested in the commissioner of human services with respect to the activities of the Division of Direct Care and Treatment; however, it did not address the composition of the executive board nor establish any new responsibilities, powers, or functions of the executive board that do not currently exist as responsibilities, powers, or functions of the commissioner. Laws 2024, chapter 127, article 50, included the language to establish the Direct Care and Treatment executive board and define the powers and duties of the executive board and chief executive officer.

Nonpartisan staff reorganized existing statutory language related to the transfer of duties for clarity and ease of use, updated terminology, and removed obsolete language.

This recodification was not intended to change existing policy or to have a fiscal impact beyond the reorganization of executive branch functions.

## **Recodified Chapters**

Below are tables showing the recodified chapters of statute and other renumbered sections of statute related to the transfer of duties from the Department of Human Services to the new Direct Care and Treatment agency.

#### **Chapter 246: State-Operated Services**

Below is a table showing the statutory organization of chapter 246, which has been modified to govern the services provided by the new Direct Care and Treatment agency. Several existing sections within chapter 246 have been renumbered and some existing sections from chapters 251 (Care of Tuberculosis Persons), 252 (Services for Persons with Developmental Disabilities), and 256 (Human Services), have been moved into this chapter. Additional services that will be administered by Direct Care and Treatment are in the existing chapter 246B (Sex Offender Program).
