

## Department of Children, Youth, and Families Statute Recodification

August 2024

## **Executive Summary**

The 2023 Legislature established a new Department of Children, Youth, and Families and directed staff to recodify statutes to transfer existing duties to the new agency. This publication illustrates the new organization of statutes governing the programs, services, and functions of state government that are transferred to the new Department of Children, Youth, and Families.

Laws 2023, chapter 70, article 12, section 35, instructed the Revisor of Statutes, in consultation with the commissioners of management and budget, human services, education, health, and public safety, to identify any changes to Minnesota Statutes and Minnesota Rules necessary to facilitate the transfer of responsibilities and related operational functions needed to implement the necessary legal changes and responsibilities related to the establishment of the Department of Children, Youth, and Families. The Revisor of Statutes was required to submit to the legislature draft legislation with the necessary statutory changes by February 1, 2024.

Laws 2023, chapter 70, article 12, section 30, lists the powers and duties of the Departments of Human Services, Education, and Public Safety that are transferred to the new Department of Children, Youth, and Families. Powers and duties transferred to the Department of Children, Youth, and Families include administration of the following programs and services:

- the child care assistance program
- certain Department of Human Services licensing functions
- certain Department of Human Services program integrity and fraud prevention activities
- early learning programs including Head Start, early learning scholarships, voluntary prekindergarten programs, early childhood family education, and school readiness
- SNAP and other food support programs
- MFIP
- Northstar care for children
- juvenile justice programs

Additional duties transferred to the Department of Children, Youth, and Families without recodifying statutes include child protection activities, maltreatment of minors reporting, juvenile safety and placement, and adoption.

Given the complexity and volume of the affected statutes, staff recommended recodifying by moving, or, in some cases, duplicating the affected statutes into seven new chapters of statute organized topically. Staff recommendations were introduced in a bill during the 2024 legislative session and were subsequently enacted as <u>Laws 2024, chapter 80</u>. The recodified language is found in Minnesota Statutes, chapters 142A to 142G. The new statutes are organized as follows:

- <u>Chapter 142A</u>: Department of Children, Youth, and Families (below)
- <u>Chapter 142B</u>: Department of Children, Youth, and Families Licensing (page 24)
- <u>Chapter 142C</u>: Certified License-Exempt Child Care Centers (page 40)
- <u>Chapter 142D</u>: Early Care and Learning (page 44)
- <u>Chapter 142E</u>: Child Care Assistance Program (page 53)
- <u>Chapter 142F</u>: Food and Community Support Programs (page 64)
- <u>Chapter 142G</u>: Minnesota Family Investment Program (page 68)

Nonpartisan staff also recommended reorganizing the affected language for clarity and ease of use and removed obsolete language. The law is effective July 1, 2024.

This recodification is not intended to change existing policy or to have a fiscal impact beyond the reorganization of executive branch functions and the establishment of a new state agency.

## Chapter 142A: Department of Children, Youth, and Families

This chapter lays out the specific powers and duties of the Department of Children, Youth, and Families, administrative hearing procedures, fraud prevention activities, children's trust fund administration, administration of various grant programs, administration of juvenile justice programs, and administration of the Northstar Care for Children program. The language in this chapter is primarily transferred or duplicated from the current chapters of statute governing the Department of Human Services (Minn. Stat. chs. 245 and 256), Community Social Services (Minn. Stat. ch. 256E), Northstar Care for Children (Minn. Stat. ch. 256N), and the Department of Public Safety (Minn. Stat. ch. 299A).
